Fighting penalties are still in effect as per last season......You can take the Trainers Course on line now but they strongly suggest you take it in person. It is cheaper and you get all the manuals. All coaching clinics and PRS clinics are now separate. You do not get PRS with the Coaching clinic......Bill Hutton OMHA Risk advised all associations to make sure they have a complaints committee in place. All altercations (verbal or physical) that take place outside of an OMHA sanctioned game or event are the concern of the local police not the Minor Hockey Association......Teams playing non contact hockey are NOT allowed to participate in contact tournaments.....Increased fees have come in effect this season for the Referees and Linesmen. Please see your new OMHA Manual.

Carson Wyatt - Acting Treasurer/Acting Assoc. Head Coach: Signing authority with the bank has been changed. Budget was handed out and discussed.
