REPORTS:

Trevor Bolt- President - must discuss with OMHA and GBTLL that the kids want a trophy for a championship, not a plaque. Coaches appliacitons are due June 15. Will try to have the process standardized. Also, will aim to have the try out process standardized. Tim and Brandon will be involved in the process. Will look at other websites. Marty Van Delan had a good resource for try outs that we may be able to use. Would like to limit meeting times, if reports could be sent to Meagan ahead of time, that may help. The team coming into Angus is a "rogue league" that is not sanctioned by the OMHA, it costs \$6000+ to play per year. We may lose 2 -3 players. We are not to be involved with the league, at the arena (no ticket sales, program sales, 50-50 etc). We will look into billets, and if we are we allowed to host a player in our home. We must follow the rule, with respect to who is covered with hockey canada.
