EXECUTIVE REPORTS:

We should only take 40 timbits, it will be the first 40 that registered. A refund policy taking the pandemic and a possible closure into account needs to be created and shared with our membership. The refund policy will be structured to included a non-refundable portion which is based on a fixed cost (to cover coaches/trainers courses, equipment) and will take into account the number of ice times we are able to have before the closure occurs. We will have to confirm with the township that we won't be expected to pay for the ice costs if a closure occurs.
