OMHA Rep - Kim Chittenden (Acting) - GBMHL Meeting April 8/25 - Tournament Conveyor for GBMHL will be holding a meeting in early September with all of the centres Tournament Directors to discuss process. Spring tryouts - ensure that coaches and on-ice help has up to date VSC, declaration and RIS. Ensure you have parents email at the start of tryouts for offers, want to be ready to go. Need to decide on timeframe of offer i.e. 24-48 hours etc. OMHA AGM coming up in June - there will be a vote for U9 full ice, there will be a vote on minimum rosters for Rep - looking at 15 (13 players 2 goalies). Rule 11.4 is under review - possible different lengths of suspension based on severity. Scheduling meetings TBD, on the table is Sept 28th for Rep, Oct 6th for LL. Rep games can start on October 1st.
